## **Chipping Campden History Society ( CCHS ) DATA PRIVACY NOTICE**

**Your personal data – what is it?** Personal data relates to a living individual who can be identified from that data. Identification can be by the information alone or in conjunction with any other information in the data controller's possession or likely to come into such possession. The processing of personal data is governed by [the General Data Protection Regulation 2016/679 (the "GDPR")<sup>1</sup>].

**Who are we?** Chipping Campden History Society ( CCHS ) is the data controller (contact details below).

**How do we process your personal data?** CCHS complies with its obligations under the GDPR by keeping personal data up to date; by storing and destroying it securely; by not collecting or retaining excessive amounts of data; by protecting personal data from loss, misuse, unauthorised access and disclosure and by ensuring that appropriate technical measures are in place to protect personal data.
